Councillor Gamble informed that there were no Speedwatch events to report. It was also reported that a parish resident has completed the training required to become an approved volunteer Community Speedwatch Operator for the scheme. It was

Councillor Dale reported that the County Council budget had been reviewed and was deemed to be operating satisfactorily. She also reported that a review of Adult Social Care and Health (ASCH) had been carried out by Newton Europe (NE), a consultancy; recommendations will be made to improve current systems and based on these, a trial will be carried out in one area and if successful rolled out across the County. It was also reported that the County Council Cabinet Meeting considered actions to combat climate change such as the introduction of a fleet of electric vehicles, a programme of tree planting to help with flood protection and removal of CO2 from the atmosphere and also plans to investigate the possibility of Hydro power. It was also reported that there had been a presentation by Healthwatch Derbyshire relating to concerns about a higher prevalence of child tooth decay in the County.

(v) Report of the District Councillor

District Councillor T Kirkham reported that the District Council faced the challenge of trying to secure more funding for the Bolsover District from the Local Enterprise Partnership (LEP) Derby Derbyshire Nottingham Nottinghamshire(D2N2). He also reported that historically Bolsover District has received funding from the EU which, in future, may not be available depending on the relationship between the UK and the EU.

It was also reported that concerns had been expressed about the planned route of HS2, especially with regard to the former Coalite Site and Hardwick Hall.
