- 3. Public Speaking A period of not more than 15 minutes was made available for members of the public and Members of the Council to comment on business on the agenda. No members of the public were in attendance.

Mansfield Councillors District Councillor Sharon Hartshorn attended as a member of the public. District Councillor S Hartshorn raised that she had been in touch with The Flood Rescue Team to register for training. Sharon explained that owners of The Mill in Meden Square are currently in the process of boarding up doors due to imminent flood risk as this resident has previously had their basement flooded. There is a flood warning in place for the next 24 hours as there is a possibility of flooding taking place, alerts have been sent out to residents at risk including a plea for traffic not to access the Meden if flooding occurred again. Agencies are monitoring the situation. Mansfield Councillors District Councillor Sharon Hartshorn is also interested in helping with Speed watch training and activities.

(2) Report from and Questions to County Councillor Ms C Dale.

DCC 33 million deficit – District Councillor C Dale asked the financial officer if Statutory duties who could be met this financial year. Children care and Adult Care account for half of the funds. School meals going up 40%. It's the families on low income that suffer in those circumstances – which schools not consulted.

(3) Report from District Councillor T Kirkham (sent via email)

Over the last month working with District Councillors John Ritchie and Catherine Tite I have done case work largely in the New Houghton area. A large proportion of this has been responding to residents' concerns regarding the application for a traveller site on Chesterfield Road.

I addition numerous council properties are suffering from damp. Although new roofs have been installed on Coronation Ave issues with pointing and damp courses remain.

I am meeting with residents with John and Catherine to discuss these issues. In addition, there has been complaints in New Houghton of antisocial behaviour. We have a meeting with the police and ASB team from BDC on Friday to see what action can be taken.

The minutes of the previous meeting on 6th November 2023 the Councillors discussed setting up a separate committee group regarding grant writing and to get the traffic control signs and funding to help repair the Verney. Councillors to discuss setting a date for this working group with working group with Councillors I Allen, C Dale, L Symth and District Council T Kirkham. Clerk to coordinate a suitable date via email.

Following the minutes of previous meeting regarding increasing fees of The Open-Door Computer Club where it was agreed that from the 1st January 2024 that non-residents should pay £3 per visit rather than the current £2 fees. Councillors to discuss whether non-residents attending The Chair Exercise Class held at the Verney should also pay a similar increase from the 1st January 2024. The Clerk has spoken to the Class Instructor Julie Bonsall who has confirm that other classes that she runs at other venues charge £3 for non-residents and responded that a £1 increase is reasonable as the fees have been the same for the previous 7 years since starting the group. All in favour of increase from January 2024.

No change in condition of play equipment at recreation grounds at Terrace Lane Pleasley and Rotherham Rd New Houghton since last month's Annual Inspection by Bolsover District, Council – continue to monitor. Some Graffiti present on post of multi – use frame at New Houghton – Bolsover District Council to remove.

ii) Email of 6/11/23 Matthew Connley, Special Projects Officer, Leisure Services at Bolsover District Council RE Single Swing at Terrace Lane which was marked as medium risk on the recent annual inspection; having looked back through our records, this has been flagged up before so is one to monitor.

(8) Next edition of the Pleasley Parish Council's Newsletter – Councillors need to be more proactive to contribute to the newsletter. Next newsletter due in March 2024 including sponsorship opportunities. Councillors discussed the fees for advertisements in future newsletters. Councillors decided the fees for advertisements in the newsletter will be £25 for Local Business that fall within the Parish, and fees for businesses that fall outside of the Pleasley will be £40. Council L Symth proposed, and this was seconded by Councillor C Dale – all councillors in favour – passed.

The Clerk received a call from Mrs Simpson of New Houghton who called today to remark how she was enjoying the article on THE BIRTH OF NEW HOUGHTON in the current newsletter.

Mrs Simpson asked if any future articles could also include the Maltby family who she believes were also large family in the village at that time. Noted

- (9) Live and Local reports future booking arrangements. Four concerts in this season: Sonrisa in September, Old Spot in November, Cri du Canard in February 24th and Grace Smith Trio March 16th. Councillor M Gamble reported that we haven't attracted the pre-covid audiences. Councillor M Gamble is working with a Bolsover District council regarding promoting "a Cultural corridor" in the Bolsover area to explore increasing attendance to ours and nearby events.

- (11) Update from Councillor L Radford to discuss the arrangements for Santa to visit the Verney for the children of Pleasley on the 17th December 2023. Offer made to use the Verney car park for Santa to park. Councillor L Radford reported Santa Sleigh may be too large for car park and that the Rotary Club usually park on the road. Adverts to be placed on local social media and local notices.
- (12) Correspondence (not quoted elsewhere in agenda)
- Email of 16/11/23 from Robert Griffith of Civil Pride. The Clerk has been in touch with Civic Pride to ask if we can re-negotiate the Christmas Lights contract for year 2 (2024) and year 3 (2025)

The offer is to amend the contact to 12 No Hire, Install & Dismantle Christmas Motifs, based on the remaining 2 Years at a Contract rate of £2700.00 (£225.00 ea.) plus VAT per annum.

The original contractor was for 18 motifs for years 2 & 3 to be £4050 plus VAT (which is a reduction of £1350 per annum.

Councillors decided to refer the discussion on whether to approve the reduced number of lights 2024/5 to help balance the budget for 2024/25 to the next budget meeting with the final decision taken at a future Parish Council meeting in the new year.

I am reaching out on behalf of Restorative Nottinghamshire, collaborating closely with Nottinghamshire Police and Crime Commissioner.

Our aim at Restorative Nottinghamshire is to deliver voluntary and impartial restorative justice throughout Nottinghamshire. We facilitate positive communication for individuals affected by crime and

conflict, providing a platform for them to engage constructively with those responsible for harm caused. Our service aims to empower victims of crime, offering them the opportunity to seek answers and express the impact of their experiences. Simultaneously, we provide a platform for individuals who have caused harm, allowing them to explain, express remorse or even the opportunity to say sorry. Through our years of experience, we have witnessed the transformative power of this process in aiding individuals' recovery and fostering a path forward.

We firmly believe in the positive outcomes that restorative justice can have, not only for victims seeking resolution, but also for offenders, offering them a chance to comprehend the consequences of their actions. Thereby, reducing the likelihood of reoffending.

I would welcome the opportunity to meet with the Parish council to provide further insights into our work and what we do, exploring our services and how they could be of value for members of your community who may have been affected by crime and conflict. I would sincerely appreciate it if you could let me know of any upcoming opportunities to connect with the team – Councillors referred to this as a Nottinghamshire item – not relevant to Pleasley Parish Council.,

Our suggestion would be to use 66244, 66245, 66248 or 66253 as these are the next ones in line and close to the Ruby shop area. Cost of conversion will be £295 plus VAT. After discussion with Chairman Clerk contacted R Griffiths to notify that is too late to covert a further lamppost for this year.
- Email of 16/11/23 from Robert Griffiths of Civic Pride- "In the first instant, we must point out that we have already installed 17 No of the 18 No motif displays for this year, The one not installed due to the CCTV camera that has been installed by PPC. Obviously, only 17 No displays will be charged"
- Email of 17/11/23 from Robert Griffiths of Civic Pride confirming that the Christmas Lights in Pleasley & New Houghton will be switch on Friday 1st December 2023 at 3pm.
