well attended and more residents would be welcome. These classes are proving beneficial to the mobility of the local residents. There is a small charge for people living outside the parish. Membership is increasing on the **free** computer sessions held in the Community Centre New Houghton on Thursdays from 10am to 12 noon.



People outside the parish can attend but there is a small charge.

## April 2018

At February's Parish Council Meeting the protocol for public speaking was accepted.

**The Parish Council** was informed by the County Council that the road changes for Newboundmill Lane have gone out for tender. (Why their own work force cannot attend to it is baffling).

**The location of more defibrillators** is still being explored. We are waiting for some answers.

Several suggestions have been received in answer to the parish council's request for residents to put forward, (**What do you want**.) to improve Terrace Lane recreation ground. Many of them are adamant on dog control which is an ongoing problem nationally. It is not the dogs that want watching, it is the irresponsible dog walkers that need educating on dog behaviour.

A similar notice is in this newsletter, this time for New Houghton Recreation Ground. (**What do you want)** to improve facilities on your recreation ground.

In the next few months with so many of our rules and regulations on cemetery procedure having been ignored in the recent years, it is time to concentrate on the cemetery. Some people mistakenly think what they do they have a right to do because they have paid for the grave. The explanation of a grave is a hole in the ground to receive a coffin. That's what families pay for and nothing else. They never own anything above the ground only perhaps a headstone.

**Nothing** should be added or placed on the plot without permission from the parish council. It would be in their interest to look at regulations on cemetery procedure for other parishes, they would soon see that what they have done is not allowed. Given the nature of the activities in most burial grounds and cemeteries, health and safety legislation is of particular importance.

Section 8 of the Burial Act 1855 provides for the inspection of any burial ground by a person appointed for that purpose by the Secretary of State. It is an offence to obstruct such a person in the course of his or her duties. There is, however, no regular inspection process or standing body of inspectors.

Section 23 of the Burial Act 1857 provides for an Order in Council to be made to require works to be undertaken for the purposes of preventing places of burial becoming or continuing to be <u>dangerous or</u> <u>injurious to public health.</u>

Section 1 of the Burial Act 1859 also provides that if such works are not carried out, responsibility will be passed to the relevant local authority. These provisions apply to any burial ground, not just those operated by local authorities. These provisions apply to any burial ground, not just those operated by local authorities.

Local authority cemeteries must be kept in good order and repair, as must be all buildings, walls and fences (LACO, Regulation 4). Fees may be charged at the discretion of the burial authority for burials, right to erect and maintain memorials and additional inscriptions. New legislation has recently been introduced which permits best value authorities to charge for discretionary services and those ranked highly with their Comprehensive Performance Assessment (CPA) having powers to trade. <u>Unauthorised memorials may be removed</u>, and LACO authorises the cost of doing so to be recovered from the person responsible, or their personal representative.

However, it is suggested that these latter powers should be exercised with care after giving due notice negotiating the removal by agreement, wherever possible. The parish council has given the required notice by way of notice in the Newsletter and a notice attached to all offending graves and has no alternative but to follow the course of the law required.

Paragraph 3.23 below provides some guidance on mitigating the problem of unauthorised memorials. 3.23 Informal memorialisation can present particular difficulties for managers.

Decoration of graves (and the surrounding area) with soft toys, musical ornaments and unauthorised boundary markers may serve to commemorate the deceased in an individualistic way which brings comfort to the family concerned, <u>but can appear garish and out of</u> <u>place for others, detracting from the intended ambience of the burial ground</u>.

Too rigid and austere a policy towards such memorialisation can attract criticism and encourage flouting of what may be regarded as petty bureaucracy. (This in no way is the intention of the Parish Council which wants to create a cemetery that the public can be proud of and feel welcome.) Equally, an entirely laissez-faire approach may only aggravate the incidence of inappropriate and perhaps hazardous decoration. Solutions may include: (1) Better information to families about permitted memorialisation and decoration on the grant of grave spaces or burial rights (including the reasons for limitations) these are in our rules and regulations guite clear. (2) Notices to this effect within the burial ground to discourage post-burial memorial additions, (which we did). The Parish Council is empowered to prevent a memorial from becoming or continuing to be a hazard to public safety or prevent access to other graves or restrict the digging of other graves. The Parish Council needs to be aware of: relevant health and safety legislation, the health and safety risks arising from the management of the cemetery and take appropriate steps to mitigate them and the dangers posed by unstable tombstones and all home made memorials.

The parish council cannot be held responsible to any damage done to a memorial. All memorials should be installed by a recognized monumental mason when permission and payment has been received.


Sheesham, Lotus and 'Son have established themselves as an act that has it all, combining astounding musicianship and fearless grooves with a show that is dynamic and entertaining.
